## Camp Rules & Guidelines

1. Students are expected to participate in all activities including meals, recreation, worship, etc. Please be sure to inform us if your student cannot swim.
2. Modesty in clothing. Spaghetti strap shirts are NOT allowed.
3. "Dollar Rule" is enforced on all shorts. This means that all shorts cannot be shorter than a dollar's length (6 inches) from the knee.
4. Any damage to the dorms is the responsibility of the students assigned to that dorm.
5. "Lights Out" hours are to be strictly observed.
6. No alcohol, tobacco or illegal drugs allowed. No guns, knives or fireworks.
7. Cell phones will NOT be permitted at camp. Staff and adults will have phones if students need to use them. Only staff/adults may use phones as needed.
8. MP3 players, PSP's, Gameboys and other electronic devices ARE NOT allowed.
9. No guys in girl's dorm and No girls in guy's dorms.
10. No MET Student are allowed in any non-MET dorm.
11. Absolutely **NO** P.D.A. (Public Display of Affection)
12. There will be NO roommate swapping.
13. Non-prescription pain relievers will be available - Please note if your student is allergic to any of these medications.

**General Release and Waiver of Liability**
